

NOTICE OF CHANGE IN RATES AND CHARGES
WALNUT CREEK WATER COMPANY, INC.
DOCKET NOS. W-02466A-19-0293 and W-02466A-19-0290
DECISION NO. 77642

On November 21, 2019, Walnut Creek Water Company, Inc. ("Walnut Creek" or "Company") filed an application with the Arizona Corporation Commission ("Commission") to increase its rates and charges for its water services and a request for approval of a financing application. In Decision No. 77642 dated June 30, 2020, the Commission approved increased water rates for the Company and authorized it to issue long term debt for \$161,500 to fund refurbishing/recoating of its storage tanks.

For a typical residential customer with a 5/8 x 3/4-inch meter with median usage of 4,193 gallons per month, the rates approved will result in an increase of \$8.73 per month, from \$28.47 to \$37.20, an increase of 30.66 percent.

Approval of the financing application would include an estimated loan surcharge of \$4.22 and would increase the same resident bill, as above, to \$41.42, for an increase of \$12.95, or 45.48%. The new rates and charges will be effective for all water services rendered on or after July 1, 2020.
